THE TOWN OF JOHNSTON TAXPAYERS HAVE THE OPPURTUNITY TO PAY THEIR DELIQUENT TAXES DUE FOR MOTOR VEHICLE AND TANGIBLE TAXES FOR TAX-YEARS 2009 AND PRIOR WITHOUT PENALTIES OR INTEREST THAT HAS BEEN ACCRUED, AS A RESULT OF THIS TAX AMNESTY PERIOD FROM OCTOBER 3, 2011 TO NOVEMBER 17, 2011

IN ACCORDANCE WITH RHODE ISLAND STATE LAW RELATING TO TAX AMNESTY THE TOWN OF JOHNSTON IS ACCEPTING REQUESTS IN WRITING FROM TAX PAYERS SEEKING A WAIVER OF INTEREST AND PENALTIES. IT IS UNDERSTOOD THAT THE TANGIBLE PROPERTY TAX AND/OR MOTOR VEHICLE TAX SUBJECT TO THE OVERDUE PAYMENT IS THE PROPERTY OF THE TAXPAYER AND HAS BEEN FOR THE PAST FIVE YEARS.

PRIOR TAX PAYMENTS MADE BEFORE THE FORTY-FIVE DAY AMNESTY PERIOD MAY NOT BE APPLIED OR TRANSFERED TO ANY OVERDUE BALANCES. BY SIGNING THIS AGREEMENT, THE TAXPAYER AFFIRMS THAT ANY AND ALL INFORMATION AND DOCUMENTATION PROVIDED BY THE TAXPAYER IN SUPPORT OF THIS REQUEST FOR A WAIVER OF INTEREST AND PENALTIES OF DELIQUENT TAXES PURSUANT TO THIS AMNESTY PROGRAM IS TRUE AND ACCURATE AND THAT THE TAXPAYER AGREES TO BE BOUND BY THE LEGAL REQUIREMENTS OF THE LAW OF THE STATE OF RHODE ISLAND AND THE ORDINANCES OF THE TOWN OF JOHNSTON FOR THIS TAX AMNESTY.
